OFFICE ORDER 77

No.4/32/SL/MD-MSPCL/2017/Pt.-I/ 1228-34 : In pursuance of Power Department: Government of Manipur letter no: MSPCL-1/1/2026-POW-PD dated: 15th April 2026, a Tentative Seniority List for the post of Junior Engineer (Electrical) from SL. No 1 to 56 of the combined list of JE (Elect) of the Company as on 1st April 2026 was published vide this Office Memorandum No.4/32/SL/MD-MSPCL/2017/Pt.-I/229-35 dated: 20th April 2026 inviting objections/claims/comments from the concerned officials within a stipulated period.

2. AND WHEREAS, in response to the Tentative Seniority list, representations and claims dated 28.04.2026 and 29.04.2026 were received from 4 (four) officials i.e. Kshetrimayum Nobelli Singh, Ningthoujam Premananda Singh, T. Khuisam Koireng and Sumpi Riningam regarding retention of their respective community status against their names in the Seniority List of JE (Elect).

3. AND WHEREAS, the said claims and representations were referred to the Power Department, Government of Manipur, for comments and advice. And, the Power Department in its letter no: MSPCL-1/1/2026-POW-PD dated: 30th May 2026 has conveyed the Speaking Order issued by the Department of Personnel and Administration Reforms (Personnel Division) bearing No: SEN-1/1/2026-DP-DP dated: 25th May 2026 in this regard stating that:

Para 2: "SC/ST Candidates appointed on their own merit and adjusted against Unreserved (UR) points do not lose their SC/ST status. They continue to retain their community status and may be considered for the benefit of reservation in future/further promotions, if otherwise admissible under the applicable rules/ instruction".

Para 3: "Accordingly, it is clarified that the applicants shall continue to retain their ST status. However, such retention of ST status shall not by itself confer any automatic right to promotion. Future/further promotion, including consideration against reserved vacancies, shall be governed by the applicable Recruitment Rules, reservation roster, availability of vacancies, eligibility, fitness/suitability, adequacy/inadequacy of representation, and other conditions prescribed from time to time.

Para 4: "Regarding the request for deletion of para 8 of DP's Office Memorandum dated 25.08.2022, it is observed that the said para is only a clarification regarding applicability of the Appendix illustrations for assessing inadequacy of representation in reservation in promotion. It does not alter the community status of SC/ST officers appointed on own merit against UR vacancies, nor does it take away their eligibility to be considered for reservation benefit in future/further promotions, subject to applicable rules. Therefore, no case is made out for deletion of para 8 of DP's Office Memorandum dated 25.08.2022"

4. In view of the above facts, the representations and claims dated 28.04.2026 and 29.04.2026 received from 4 (four) officials regarding retention of their respective community status against their names in the Seniority list of JE (Elect) were accepted and disposed of accordingly.

5. Therefore, the Final Seniority list for the post of Junior Engineer (Electrical) from SL. No 1 to 56 of the combined list of JE (Elect) of the Company as on 1st April 2026 in the **ANNEXURE** enclosed, is hereby fixed and published.
